The BATC Natural Health Therapist has to work according to BATC's regulations.

The cliënt/patiënt is obliged via an intake to provide the BATC Therapist with all the relevant information.

The cliënt/patiënt has the right to view his/ her own file.

The cliënt/patiënt is obliged to cancel an appointment at least 24 hours before the start of the session, if not the session will be charged.

The BATC Natural Health Therapist is obliged to give information about the treatment to the cliënt/patiënt during all phases of the treatment process.

The BATC Natural Health Therapist will keep the field information secret. During visitation files will be looked at to check if all the information is registered correctly. Personal data will be unknown to the person in charge of the visitation.

The BATC Natural Health Therapist needs the cliënts/patient's permission to apply therapeutic actions.

The BATC Natural Health Therapist is obliged to make the fees visible in her practise.

The BATC Natural Health Therapist is obliged to send the cliënt/patiënt to a general practitioner or other colleague when the treatment given isn't sufficient.

The BATC Natural Health Therapist is obliged to have a professional liability insurance.

Ending the treatment process can happen at all times if both parties agree..

The client/patient can always choose to end treatments if he is not satisfied with the proces.

If the client/patient ends treatment against advice of the The BATC Natural Health Therapist, he or she will be asked to sign a statement stating that he is ending the session against advice of the therapist at his or her own risk and responsibility.

The The BATC Natural Health Therapist can only end the treatment process without the client/patient's wishes if he has good arguments to not be able to continue the process as stated in the treatment agreement.

The The BATC Natural Health Therapist will keep on providing help until the client/patient has transferred to another healthcare provider.

Payment can be in cash or bank transfer. If you transfer the money you receive the invoice after the amount has been received by the therapist.

For complaints regarding the treatment the cliënt/patiënt can turn to 1. The therapist 2. The organisation the therapist is a part of (BATC) 3. complaint bureau CamCoop.
